Councilor Simmons: Made mention of a recent visit to other wastewater plants in Bernalillo and Rio Rancho and thanked New Mexico Rural Water for providing some alternative to what we are faced with. He encouraged anyone who wanted more information to come speak with him.

7. AN UPDATE AND DISCUSSION OF THE WASTERWATER P.E.R. by Tappan Mahoney with Dennis Engineering

Mr. Tappan Mahoney with Dennis Engineering gave an update on the Wastewater PER. Mr. Mahoney stated that he had received comments on the P.E.R. from NMED and that since then numerous correspondence, discussion and dialogue has taken place with them. He has also met with USDA and they have provided comments on the P.E.R. as well.

Mr. Mahoney stated that we have preliminary approval of the P.E.R. from NMED and USDA. He is looking at wrapping up the current P.E.R. next week. It will show phasing and cost cutting options and it will address some of the financial concerns NMED has. He feels the P.E.R. will be approved with conditions. The conditions will not be with respect to the technical content. It will have to do with financials and the need for the Town to implement the wastewater ordinance. The Town will also need to show an increase in customer base through connections, etc....

Additionally, he also provided a second P.E.R. specific to the Reuse and Disposal Project and USDA is interested in funding that project. NMED concurs that the Reuse and Disposal Project should be completed.

He then stood for questions

Councilor Simmons said she appreciated the research. She mentioned that phasing and cutting costs wherever we can will be helpful. She also mentioned that just looking at other systems, which she and the Mayor did with New Mexico Rural Water was helpful.

The Mayor asked if we would have one P.E.R. or two?

Mr. Mahoney said we would have two because USDA wanted to also see one that just addressed the Reuse and Disposal Project.

Councilor Simmons asked if we had a copy of the original scope of work that started this project. The Mayor did not believe so but Mr. Mahoney said he did have it and would bring it to Town Hall.

a. Request for appeal by Mr. Jonathan Pillars, 8 acres of land, more or less, located on Woodline Drive, known as Tract P-1-R-1-B, Section 21, T10N, R7E, NMPM, in the Town of Edgewood, New Mexico on a decision made by the Planning and Zoning Commission of the Town of Edgewood.

Councilor Abrams stated he had no conflict of interest or ex-parte communication.

Councilor Abraham stated she had no conflict of interest, but has ex-parte communication. Mayor Bassett asked if she felt she could judge this case honestly. Councilor Abraham stated yes. Mayor Bassett asked if any of the Council has concerns of Councilor Abraham hearing this appeal. No objections noted.

Councilor Simmons stated she had no conflict of interest or ex-parte communication. Councilor Ring stated he had no conflict of interest, but shook Mr. Pillars hand after a meeting. Mayor Bassett stated he has no conflict of interest or ex-parte communication.

Mayor Bassett asked if anyone present had concerns about her or any of the Council hearing this Public Hearing. No objections noted.

Mr. Larry Sullivan stated this is the second appeal by Mr. Johnathan Pillars of decisions made by the Planning & Zoning Commission on his application for approval of a minor subdivision. When the matter was first heard in August, the Council remanded the case to P & Z with directions to reconsider four requirements imposed as preconditions for final approval. Based on new evidence, P & Z rescinded three of the four conditions, but found the requirement of roadway and cul de sac improvements should not be withdrawn. Mr. Pillars is currently appealing the P & Z denial of minor subdivision approval upon his failure to show compliance with town roadway standards.

Mr. Pillars stated he is appealing due to misleading information in exhibit A, an illustration that Mr. Sullivan drew up letting Mr. Pillars know that the road way must be 20' in width. Mr. Pillars stated he created his property to image Mr. Sullivan's drawing and then was told his road did not meet town standards, as the road is required to be 24' wide.

The Council agreed to the staff illustration of exhibit A, and requested a 6" compacted base (or equivalent) with an all-weather surface. This included a cul de sac or hammer head be put in place and a 20' wide road. Mr. Pillars stated he is away at his winter home and drove in for this appeal. He mentioned he would not return until summer and believes he would need until the first meeting in August to comply with these conditions.

The towns attorney, Mr. Autio stated, an option is to wait until August 2017, and at that time have the Fire Department and the Road Supervisor, Mr. Norton Henninger confirm that the conditions set out on exhibit A have been met.

MOTION: Councilor Simmons made a motion to defer the request for appeal by Mr. Jonathan

Pillars until the first meeting in August of 2017 to meet the conditions set out on

exhibit A.

9. TOWN OF EDGEWOOD POLICE REPORT - Chief Ron Crow-

Police Report and Animal Control Report for the month of November 2016.

Chief Crow presented council with the Police Report for the month of November which stated as follows: The Police Department had 513 Dispatch Activities of which 145 were from Santa Fe Regional Dispatch and 368 were self-initiated, 79 traffic stops, issued 24 traffic citations, took 21 offense reports, 8 crash reports and made 6 arrests.

The Animal Control Division had 25 dispatch activities of which 16 were from the Santa Fe Regional Dispatch and 9 self-initiated. They took in 12 animals adopted 6 and transferred 0 to other agencies and had 10 reclaimed. Volunteers donated 83.5 hours during the month.

Chief Crow also mentioned Cops for the Holidays would be on December 22nd, 2017

MOTION: Councilor Abrams made a motion to approve the Police Report and Animal Control

10. DISCUSSION OF THE ANIMAL CONTROL ORDIANCE

a. Changes to the Animal Control Ordinance proposed by the Animal Welfare Advisory Board.

Police Chief Ron Crow and Animal Control Officer Mike Ring read off a list of proposed changes to the current Animal Control Ordinance. Most of the proposed changes involve changes, additions or clarifications to the list of definitions, refining standard for such thing as yard enclosures, setting limits on the number of animals owned and how many litters they can have and revising fees, permits and fines to better reflect actual costs.

A discussion followed during which it was decided by the Governing Body that the Town was not yet ready to move forward with a Call for a Public Hearing to discuss and act on the proposed changes.

Most spoke out defending pit bull dogs and opposed banning any specific breed of dog, People also expressed sympathy for people who felt terrorized by a recent dog attack. One gentleman spoke about

the recent dog attack which involved a group of "pit bulls" who had escaped their yard and attacked dogs being walked by neighbors ... The incident he said, left the neighbors walking their dogs extremely frightened. A gentleman who said it was dogs involved in the recent incident said his dogs were not dangerous and he invited people to his home to meet them. A few speakers offered their help as the Town looks to make changes to the Animal Control Ordinance.

Mayor Bassett invited all the speakers and all those in attendance at the meeting to attend the next meeting of the Animal Control Advisory Board on January 3rd, 2017.

12. MATTERS FROM THE CLERK/TREASURER.

a. Financial Report for November, 2016

Mr. Torres introduced the Financial Report for the month of November. He mentioned the GRT is down again which raises some concern.

He stated beginning January 2017 the Environmental Gross Receipt Tax (EGRT) will become effective, but we would not see the results until March 2017. This EGRT will be put forth to the Wastewater and will receive its own column in the GRT sheet.

Councilor Abrams is concerned with the Wells Fargo CD Fund and its criteria to meet the Department of Finance and Administration (DFA) requirements. Mr. Torres stated it does meet the DFA requirements.

MOTION: Councilor Simmons made a motion to approve the Financial Report for November 2016.

Councilor Ring seconded the motion.

VOTE: All Councilors voted aye. The motion carried.
