Councilor Holle spoke of her Citizen Input Meeting held October 6, 2018 in the Community Center. She stated the main topic of discussion was that of a community garden. Councilor Holle informed everyone about the community garden at the Edgewood Senior Center and encouraged anyone interested to participate. Planning meetings for the garden are held every 1<sup>st</sup> Thursday of every month from 1:00 PM - 2:00 PM at the Edgewood Senior Center.

Councilor Holle also reminded everyone that the General Election is on November 6, 2018 with early voting beginning on Saturday, October 20, 2018. The local polling location is at the former Edgewood Elementary School on Dinkle Rd.

B. Discussion, Consideration and Action on Resolution 2018-23: A Resolution Requiring The Prompt Removal Of Ruined, Damaged And Dilapidated Materials To Abate An Immediate Menace To The Public Comfort, Health, Peace And Safety, In The Town of Edgewood, Santa Fe County, New Mexico; Requiring The Owner Or Owners, Occupants Or Agents Of The Owners Of The Property Promptly To Commence And Complete The Removal From The Property Of All Ruined, Damaged And Dilapidated Materials, Including But Not Limited To Homes, Buildings, Constructed Structures, Remaining Debris, And Other Materials Attached Thereto And Other Flammable, Nuisance Or Noxious Materials Located On The Property; Providing That The Owner, Occupant Or Agent In Charge Of The Property May File Written Objections To This Resolution And Seek A Hearing Before The Governing Body Of The Town of Edgewood, As Provided By Statute; Authorizing The Administration Of The Town of Edgewood To Cause Removal Of The Ruined, Damaged, Dilapidated, Nuisance, Noxious, Ruins, Rubbish Or Debris, Materials and Mobile Homes, And If The Owner Or Owners Of The Property Do Not Timely Undertake Such Removal; Requiring Detailed Documentation If The Town Does The Removal; Providing That The Town of Edgewood Shall Recover Its Costs Incurred For Removal Of The Ruined, Damaged And Dilapidated Materials As And To The Extent Provided By Statute.

Mayor Bassett recused himself from this Action Item and left the room. Councilor Abrams, Mayor Pro-Tem acted in his place.

Councilor Abraham asked if anyone was currently living on the property. Michelle Schmidt, Code Enforcement Officer for the Town of Edgewood, stated no one was currently living on the property. Ms. Schmidt added that the property owners had been issued courtesy notices and citations. The shed that had been occupied had not been permitted and was marked as "non-human occupancy". Councilor Abraham asked if there were any environmental hazards on the property. Ms. Schmidt answered in the affirmative. Councilor Abraham then asked if NMED should come out. Ms. Schmidt stated that they met enough other requirements and she didn't think there was a need for NMED to come out.

Mayor Bassett requested certification that public notice of this Hearing had been posted as required. Ms. Carla Salazar answered in the affirmative.

This is a Legislative Public Hearing called for the purpose of considering adoption of Ordinance 2018-09. An Ordinance adopting the New Mexico Uniform Traffic Ordinance by Reference; repealing Ordinance 2017-01.

Chief of Police Ron Crow stated that no changes have been made to the Ordinance with the exception of the addition of the Penalty Assessments, which is the next item on the Agenda.

Chief Crow stated that except for Court Costs, the Penalty Assessments are showing a \$10 increase in the majority of the fines.

PUBLIC HEARING (Quasi-Judicial): Discussion, Consideration and Action on the Application of Estancia Valley Classical Academy Foundation for a Zone Change of 20 acres, from Residential R-1, to SU Special Use, located at 110 NM 344, Lone Pine Ranch Subdivision A-2, T10N R7E SEC 22 NMPM, in the Town of Edgewood, Santa Fe County, New Mexico.

Ms. Mortensen stated this Zone Change recommendation was staff driven as schools are typically zoned Special Use. Planning and Zoning contacted the Estancia Valley Classical Academy and asked if they would submit an application for Zone Change, which was done.

R-1, to SU Special Use, for the Estancia Valley Classical Academy located at 110 NM 344, Lone Pine Ranch Subdivision A-2, T10N R7E SEC 22 NMPM, in the Town of Edgewood, Santa Fe County, New Mexico. Councilor Holle

seconded the motion.

**VOTE:** Councilor Jaramillo voted aye. Councilor Holle voted aye. Councilor Abrams
