## CALL TO ORDER.

Mayor Bassett called the meeting to order at 6:30 p.m.

## D. Matters from the Mayor

The Celtic Festival, held on October 20, drew a crowd of 1800-2000 people. The event sponsors would like to stage the event in Edgewood again next year.

Mayor Bassett and Councilor Holle (First Choice Community Healthcare (FCCH) Board Member) attended the UNM School of Medicine Alumni Reunion Awards Dinner, where FCCH received the Alumni Association's 2018 Visionary Site Award. The award recognizes NM health systems that embody the mission of the UNM School of Medicine. Edgewood is home to one of FCCH's 9 clinics.

Mayor Bassett attended a Special Prayer time at the new Estancia Valley Classical Academy (EVCA) on October 28<sup>th</sup>, sponsored by the Good Shepherd Lutheran Church Men's Prayer Group. He had the opportunity to tour the school as well. The Mayor also attended EVCA's formal ribbon cutting and public grand opening on November 10.

The Edgewood Police Department held their annual Halloween Trunk or Treat event in the parking lot in front of the Library on October 31. It was well attended, even though it was a cold evening.

The first Public Meeting to obtain citizen input on the Town's Comprehensive Plan Update was held November 13, with a second Public Meeting scheduled November 20. The public is encouraged to attend and share their ideas with the committee.

The Mayor issued a reminder that the Santa Fe County Treasurer's Office will be accepting property tax payments at the Senior Center on November 19 and 26 from 10:30 a.m. -1:00 p.m.

Mayor Bassett reported the new Town website has been rolled out and requested feedback of the site.

The Mayor announced that Ms. Destiny Price has joined the Town Staff as an intern from Workforce Solutions.

Mayor Bassett encouraged all to attend the Town's 3<sup>rd</sup> annual Christmas tree lighting on December 7 at the soccer field. The event will include musical performances by area schools, free refreshments and a bonfire.

Lastly, Mayor Bassett congratulated Ms. Leota Harriman's recent election to President of the New Mexico Press Association and wished her well for her tenure at the Association. Ms. Harriman is Editor and Publisher of The Independent newspaper.

#### d. Councilor Linda Holle

Councilor Holle, Board Member of the NCRTD (North Central Regional Transit District), announced that Mr. Michael Broussard, NCRTD's Edgewood bus driver, was awarded NCRTD's Above and Beyond Award 3<sup>rd</sup> Quarter 2018 for outstanding customer service. Councilor Holle also thanked all who supported the NCRTD GRT Reauthorization Bond in the recent election. 73.37% of the voters in Santa Fe County voted for the reauthorization.

Councilor Holle reported that NMSU will offer a Master Gardener program in 2019. Classes will meet on Thursdays 6 p.m. - 9 p.m., February 7 – May 2 in Moriarty. The cost for all course materials is \$120. Contact Torrance County Extension Office for more information.

## F. Matters from the Clerk/Treasurer

a. Update on the Wastewater System

Clerk/Treasurer Juan Torres gave an update on the notice of violation from NMED (New Mexico Environment Department). He stated that the Town responded in writing to the violations and as soon as he receives a response from NMED he will schedule a meeting for NMED to update the Governing Body. He also stated that Auto Zone has connected to the waste water collection system. Deputy Clerk Carla Salazar provided an update on the waste water collection system project and showed pictures of the construction work being done. She stated the project was on time and on budget.

b. Arts in Public Places

Mr. Juan Torres stated he has checked into getting some local art work put up in the building but the selections from Arts in Public Places were very slim. The Town will be looking into other options of local artists that would like to display their work in the building.

## V. ACTION ITEMS

A. PUBLIC HEARING (Legislative): Discussion, Consideration and Action on Ordinance No. 2018-11 Authorizing the Town of Edgewood ("Borrower") to enter into a loan agreement with the New Mexico Environment Department ("NMED") for the purpose of obtaining Project Loan Funds in the principal amount of \$450,000.00 and Loan Subsidy Grant Funds in the amount of \$200,000.00 for a total funded amount of \$650,000.00 to be heard November 14<sup>th</sup>, 2018.

Clerk/Treasurer Juan Torres spoke about getting screens put in at the sewer plant. Councilor Sherry Abraham asked if there were funds left over if the excess funds would go towards the violations. Deputy Clerk Carla Salazar advised that was a possibility.

Mr. Tom McGill, questioned the loan and inquired if it had been taken into consideration to have enough funds to pay the violations. It was explained that when the Town estimated the funding needed for the waste water plant no violations had been cited.

Mr. McGill also asked if the Town had taken soil samples. Mr. Juan Torres stated that the Town had done soil sampling and the results were good.

Mr. Bradley requested that he be given the chance to clean up the property on his own before the Town did it and put a lien on the property. It was agreed that Mr. Bradley would have until December to show that he is able to have the property cleaned. Ms. Michelle Schmidt will get a bid in case Mr. Bradley can't get the cleanup done.
