**SPECIAL ELECTION RESOLUTION
TOWN OF EDGEWOOD
Resolution No. 2020-09**

WHEREAS, a verified petition under Subsection A of Section 3-14-2 NMSA 1978 manager was filed with the Town Clerk on March 23, 2020, seeking to organize the Town under the commission-manager form of government: and

WHEREAS, the Clerk has verified that the petition contains a sufficient number of legal signatures, having determined that the petition contains the signatures of at least fifteen (15%) of the qualified electors who voted for the office of mayor in the last local election:

BE IT RESOLVED by the Governing Body of the Town of Edgewood, New Mexico that:

1. A Special Election is hereby proclaimed to be held on **August 24th, 2020** for the purpose of submitting the following ballot question to the qualified electors of the Town of Edgewood with respect to whether the Town of Edgewood should be organized under the council manager form of government:

FOR or AGAINST:

Shall the Town of Edgewood be organized under the commissioner-manager form of government and providing for the election of five commissioners?

_____ ***FOR** the commission-manager form of government and providing for the election of five commissioners.*

_____ ***AGAINST** the commission-manager form of government and providing for the election of five commissioners.*

[Voter may only choose one of the above]

2. The aforesaid Special Election shall be conducted by mailed pursuant to the provisions of the Special Election Act (NMSA 1978 §1-24-1 through §1-24-5).

3. The Clerk is hereby directed to file this resolution with the county clerk of each county containing any precinct in which votes may be cast for or against the aforesaid ballot question.

4. This Resolution supersedes Resolution 2020-06.
