ELECTION RESOLUTION NO. 2009-45

Be it resolved by the governing body of the Town of Edgewood of Edgewood, New Mexico that:

- A. A regular municipal election for the election of municipal officers shall be held on March 2, 2010. Polls will open at 7:00 A.M. and close at 7:00 P.M.
- B. At the regular municipal election, persons shall be elected to fill the following elective offices:
1. ONE Councilor for a four year term.

- C. The following questions shall be submitted at the regular municipal election:
- FOR or AGAINST:**
General Obligation Street Bonds: Shall the Town of Edgewood issue \$2,100,000 of its general obligation bonds to study, design, develop, construct, reconstruct, rehabilitate, renovate, automate, modernize, sign, enhance, landscape and otherwise improve, and to acquire land and equipment for municipal streets and roads?
- FOR or AGAINST:**
General Obligation Public Building and Facility Bonds: Shall the Town of Edgewood issue \$2,100,000 of its general obligation bonds to design, develop, study, construct, modernize, automate, renovate, rehabilitate, recondition, landscape, furnish, equip, enhance and other improve, and to acquire land and buildings, apparatus, and equipment for town buildings and facilities, including facilities in the Public Works Department, Municipal Administration, and Library.
- D. Precincts 15, 18, 73, 84, and 85 are consolidated for the regular municipal election.
- E. The following location is designated as the polling place for the conduct of the regular municipal election:
1. Voters from precincts 15, 18, 73, 84, and 85 shall vote at the Edgewood Community Center, #27 E. Frontage Road, Edgewood, New Mexico.
- F. Absentee Voting. Applications for absentee ballots may be obtained only from the office of the Municipal Clerk. All applications for an absentee ballot must be


completed and accepted by the Municipal Clerk prior to 5:00 p.m., February 26, 2010. After 5:00 p.m. on February 26, 2010, all unused absentee ballots will be publicly destroyed by the Municipal Clerk. The Municipal Clerk will accept completed absentee ballots delivered by mail, or in person by the voter casting the absentee ballot or by a member of the voter's immediate family, until 7:00 p.m. on March 2, 2010.

Absentee ballots may be marked in person in the office of the Municipal Clerk during the regular hours and days of business, beginning on Tuesday, January 26, and closing at 5:00 p.m. on Friday, February 26, 2010.


Early Voting. Early voting on paper ballots counted by the M100 electronic vote tabulator will be conducted in the office of the Municipal Clerk during the regular hours and days of business, beginning on Wednesday, February 10, 2010 and closing at 5:00 p.m. on Friday, February 26, 2010.

- G. Persons desiring to register to vote at the regular municipal election must register with the County Clerk of Santa Fe County not later than Tuesday, February 2, 2010 at 5:00 P.M., the date on which the County Clerk will close registration books.
- H. All Declarations of Candidacy shall be filed with the Municipal Clerk on Tuesday, January 5, 2010 between the hours of 8:00 A.M. and 5:00 P.M.
- I. The casting of votes by qualified municipal electors shall be recorded on paper ballots to be counted by the M100 electronic vote tabulators.
