WHEREAS, owners of a majority of 820.73 acres of territory contiguous to the current north, south, and west boundaries of the Town of Edgewood petition the Town to annex the territory; and

WHEREAS, the annexation petition delivered to the Town Mayor complies with the requirements of NMSA 1978, S3-7-17 (Repl. Pamp 1987) and was, prior to signature by petitioners, duly approved by the Town Mayor acting on behalf of the office of Town Clerk since the Town began official business on July 1, 1999 and has not yet appointed a Town Clerk pursuant to NMSA 1978, S3-1-5 (Repl. Pamp. 1987) and

WHEREAS, in particular, the annexation petition is accompanied by two maps labeled Exhibits "A" and "B" showing respectively, the external boundary of the territory proposed to be annexed and the relationship of such territory to the existing Town boundary; and

WHEREAS, the governing body of the Town of Edgewood has determined that the Town is capable of providing municipal services to the territory proposed to be annexed within a reasonable time and that the annexation is in the best interests of the Town as a whole.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF EDGEWOOD THAT:

The territory described and defined in the maps attached hereto as Exhibits "A" and "B" is hereby annexed to the Town of Edgewood and is hereby made subject to all of the laws and ordinances which shall now or hereafter apply to land within the Town limits.

Further, the Council hereby directs the Town Clerk to file a copy of the maps of the annexed territory in the office of the Clerk of Santa Fe County and of any other County in the event the annexed territory extends into another County and to send copies of the ordinance and of the maps of the territory so annexed to the Secretary of Finance and



Regular Session August 4, 1999

TIME, PLACE & ATTENDANCE

The Governing Body of the Town of Edgewood met in regular session on August 4, 1999 at the Edgewood Community Center.

The following members were present: Mayor Larry Keaty; Council members Howard Calkins, Gary Chemistruck, Chuck Ring and Bob Stearley. Also present was Karen Alarid, Town ClerkTreasurer; Carole Apple, Municipal Judge. See attached rooster for others in attendance.

PLEDGE OF ALLEGIANCE

Mayor Keaty lead the Governing Body and visitors in the Pledge of Allegiance.

APPROVAL OF MINUTES

Councilor Chemistruck moved to approve the minutes of the July 19, 1999 as correct. Councilor Ring seconded the motion. All voted aye. Motion carried.

PUBLIC HEARING

Mayor Keaty advised the audience that this was a public hearing and he would be taking comments from residents in the incorporated limits first, then from others.

ORDINANCE 1999-C ANNEXATION OF 820.73 ACRES

Councilor Callkins moved to approve ordinance #1999-C reference annexation of 820.73 acres. Councilor Ring seconded the motion. All voted aye. Motion carried.

ORDINANCE 1999-D ANNEXATION OF 335 ACRES

Councilor Chemistruck moved to adopt Ordinance #1999-D reference annexation of 335 acres. Councilor Calkins seconded the motion. All voted aye. Motion carried.

ORDINANCE 1999-E MGRT - 5%

Councilor Ring moved to approve ordinance #1999-E reference imposition of .5% municipal gross receipts tax. Councilor Stearley seconded the motion. All voted aye. Motion carried.

ORDINANCE 1999-F MGRT - 1/8%

Councilor Chemistruck moved to adopt Ordinance #1999-F reference imposition of 1/8% municipal infrastructure gross receipts tax. Councilor Stearley seconded the motion. All voted aye. Motion carried.

RESOLUTION 1999-3 LEASE-OFFICE

Councilor Calkins moved to approve resolution #1999-3. Councilor Stearley seconded the motion. Councilor Chemistruck moved to change the \$450.00 per month fee to \$465.00. Councilor Stearley seconded the motion. All voted aye. Motion carried. All voted aye to approve resolution 1999-3 as amended. Motion carried.

RESOLUTION 1999-4 BUDGET

Councilor Ring moved to approve the budget as presented for fiscal year 1999-2000. Councilor Calkins seconded the motion. Councilor Chemistruck moved to modify the budget to reflect deletion of Elected Officials salary (\$6,000), and adding mileage and per diem under the legislative section with \$3000. 00 each for a total of \$6,000. Councilor Stearley seconded the motion. Councilors Chemistruck, Ring and Stearley voted aye. Councilor Calkins voted nay. Motion carried. Councilors Chemistruck, Ring, Calkins and Stearley voted to approve the budget as amended. Motion carried.

RESOLUTION 1999-5

Councilor Calkins moved to approve resolution #1999-5 reference opening banking accounts necessary for the town business. Council Ring seconded the motion. All voted aye. Motion carried. Council Ring moved to authorize the Mayor to select one other member of the council to sign bank signature cards. Councilor Chemistruck seconded the motion. All voted aye. Motion carried.

RESOLUTION 1999-6

Councilor Chemistruck moved to approve resolution #1999-6 reference amending resolution #1999-1, Open Meetings Act. Councilor Stearley seconded the motion. All voted aye. Motion carried.

WORK SESSION RFP-ENGINEERING

Mayor Keaty said he would like to have a work session with the Council to go over the request for proposals received for engineering services. The Council agreed to meet Monday August 9, 1999 at the Homestead Restaurant at 6:30 p.m.

LIQUOR

Mayor Keaty advised those present that an inquiry had been received reference establishing a package liquor store within the town limits. The Mayor asked for a show of hands for those in favor of such an establishment. The overall consensus opposed, however, they may consider allowing a restaurant to serve beer and wine. After considerable discussion, it was agreed that the Town would get a copy of the laws pertaining to liquor sales and also request that someone from the state meet with the Councilors on this matter.

TAX & REV.

Councilor Stearley advised the Council that he had a letter from Taxation & Revenue that can be given to the businesses within the Town with the correct reporting location code. Wally Gordon with the Independent suggested that this information be published in the newspaper.

Councilor Ring stated that the Town could use the registration list of businesses from the County of Santa Fe.

CELEBRATION

Councilor Ring said that the dedication of the town celebration was very nice. On behalf of the Governing Body, he wanted to recognize Diane Stearley, Lynn Lawlor and Frank Lasky for all the work they did. The celebration was big success because of the support from the businesses and other individuals. Mr. Lasky advised the Council that the Lions Club made \$248.00 for their eye glass fund. Diane Stearley stated that their was some money left over (\$700.00 - 1,000.00) which will be donated to a charitable organization.

JUDGE'S REPORT

Karen Alarid advised the Council that Municipal Judge Apple has submitted a court report for the month of July. 0 fines, 0 fees and 0 cases.

ADJOURN

There being no further business Councilor Chemistruck moved to adjourn. Councilor Ring seconded the motion. All voted aye. Motion carried.
