**A RESOLUTION
ESTABLISHING A SCHEDULE OF FEES AND OTHER ASSIGNABLE COSTS
RELATED TO THE CARE AND CONTROL OF ANIMALS WITHIN THE
TOWN OF EDGEWOOD, SANTA FE COUNTY.**

WHEREAS: the Governing Body of the Town of Edgewood has duly passed and adopted an Animal Care and Control Ordinance for the Town of Edgewood; and

WHEREAS: the governing Body of the Town of Edgewood deems it necessary and proper to establish a Schedule of Fees and other Assignable Costs in order to help achieve the requirements and purposes of said Ordinance;

**THEREFORE: BE IT RESOLVED BY THE GOVERNING BODY OF THE TOWN
OF EDGEWOOD THAT:**

The Town of Edgewood hereby establishes a Schedule of Fees and other Assignable Costs related to the Care and Control of Animals within the Municipal boundary of the Town of Edgewood, which Schedule is attached hereto as:

EXHIBIT "A"
FEE SCHEDULE

A. LICENSING

Licensing fees are to be collected upon the licensing of animals owned by persons living within the municipal boundaries of The Town of Edgewood by the Animal Care & Control Department;

- a) Un-sterilized Male/Female \$10.00
- b) Sterilized Male/Female \$3.00
- c) Potentially Dangerous \$100.00
- d) Dangerous \$1000.00
- e) Tag Replacement \$5.00
- f) Late fee \$5.00

B. IMPOUNDMENT FEES

1. DOGS

- a) 1st offense \$20.00
- b) 2nd offense within calendar year \$30.00
- c) 3rd offense in calendar year \$40.00
- d) Any additional offenses within the calendar year will be increased by \$10.00
- e) Boarding cost \$10.00 per day.

2. CATS

- a) 1st Offense \$15.00
- b) 2nd offense within calendar year \$25.00
- c) 3rd offense within calendar year \$35.00
- d) Any additional offenses within the calendar year will be increased by \$10.00
- e) Boarding cost \$8.00 per day.

3. LIVESTOCK

Boarding cost (per day) to be determined by Animal Care & Control Department.

4. BIRDS & REPTILES

Boarding cost (per day) to be determined by Animal Care & Control Department.

5. DEAD ANIMAL PICK-UP AND DISPOSAL FEES

Pick-up and disposal fees to be determined by Animal Control Personnel.

6. MICROCHIPPING FEES

Microchipping fee to be determined by Animal Control Personnel, which shall include registration fees.

7. ADOPTION FEES

Adoption fees to be determined by Animal Care & Control Department and will include sterilization deposit when applicable.

C. PERMIT FEES

1. CONDITIONAL USE PERMIT	\$50.00
2. GUARD DOG PERMIT	\$50.00
3. HOBBY BREEDER PERMIT	\$150.00
4. LITTER PERMIT	\$50.00
5. INTACT PERMIT	\$50.00
6. WILD ANIMAL PERMIT	\$50.00
7. MULTIPLE ANIMALS PERMIT	\$50.00

D. STERILIZATION DEPOSIT

For the redemption/reclaiming or adoption of any unsterilized Companion Animal, the owner/custodial person shall pay a sterilization deposit of not less than \$25.00.

E. FINES FOR VIOLATIONS

Any person who violates a provision of this article shall be deemed guilty of a petty misdemeanor, and upon conviction thereof, shall be subject to the penalty provisions set forth in this Ordinance. Each day this article is violated shall be considered a separate offense. Where the defendant has been convicted of a crime constituting a petty misdemeanor, the judge shall sentence the person to be imprisoned in the county jail for a definite term not to exceed six months or to the payment of a fine of not more than five hundred dollars (\$500.00) or to both such imprisonment and fine in the discretion of the judge.

F. ASSIGNMENT OF FINES AND FEES

Licensing, Impoundment, Microchip, Permit, and Adoption fees and Animal Control Fines collected are to be used solely by the Animal Care & Control Department for such uses as planning, constructing, maintaining, and operating animal control facilities. Funds also to be used to implement a low-cost pet sterility program for people residing within the Town of Edgewood, providing funding for reduced fee pet sterility programs in conjunction with or as an alternative to already established non-profit spay / neuter programs and to provide various other animal related clinics to the public.
