Total amount for the purchase of two (2) 4x4 vehicles is \$65,398.00.


Police Special Revenue Fund – Capital Purchases (Account Code 299-05-48070 – Vehicles). To increase in the amount of \$45,398.00.

(Law Enforcement Protection Fund – To be expended in the amount of \$20,000.00 for balance of the vehicles purchased).
