

ELECTION RESOLUTION

TOWN OF EDGEWOOD

Resolution No. 2013-21

Be it resolved by the governing body of the Town Edgewood of Edgewood, New Mexico that:

- A. A regular municipal election for the election of municipal officers shall be held on March 4, 2014. Polls will open at 7:00 A.M. and close at 7:00 P.M.
- B. At the regular municipal election, persons shall be elected to fill the following elective offices:
 - 1. ONE Councilor for a four (4) year term
 - 2. ONE Councilor for a four (4) year term
- C. The following question(s) shall be submitted at the regular municipal election:
 - FOR or AGAINST:**
General Obligation Street Bonds: Shall the Town of Edgewood issue \$3,000,000.00 of its general obligation bonds to study, design, develop, construct, reconstruct rehabilitate, renovate, automate, modernize, sign, enhance, landscape and otherwise improve, and to acquire land and equipment for municipal streets and roads?
 - FOR or AGAINST:**
General Obligation Public Building and Facility Bonds: Shall the Town of Edgewood issue \$670,000.00 of its general obligation bonds to design, develop, study, construct, modernize, automate, renovate, rehabilitate, recondition, landscape, furnish, and equip, a facility for an Animal Shelter.
- D. Precincts 15, 18, 73, 84, & 85 are consolidated for the regular municipal election.
- E. The following locations are designated as polling places for the conduct of the regular municipal election:
 - 1. Voters in Precincts 15, 18, 73, 84, & 85 shall vote at the Edgewood Community Center, #27 E. Frontage Road, Edgewood, New Mexico.
- F. Absentee Voting. Applications for absentee ballots may be obtained only from the office of the Municipal Clerk. All applications for an absentee ballot must be completed and accepted by the Municipal Clerk prior to 5:00 p.m., February 28, 2014. After 5:00 p.m. on February 28, 2014, all unused absentee ballots will be publicly destroyed by the Municipal Clerk. The Municipal Clerk will accept completed absentee ballots delivered by mail, or in person by the voter casting the absentee ballot, by a member of the voter's immediate family, or by the caregiver to the voter until 7:00 p.m. on March 4, 2014.

Absentee ballots may be marked in person in the office of the Municipal Clerk during the regular hours and days of business, beginning on Tuesday, January 28, and closing at 5:00 p.m. on Friday, February 28, 2014.

Early Voting. Early voting on paper ballots counted by M100 electronic vote tabulator will be conducted in the office of the Municipal Clerk during the regular hours and days of business, beginning on Wednesday, February 12, 2014 and closing at 5:00 p.m. on Friday, February 28, 2014.

- G. Persons desiring to register to vote at the regular municipal election must register with the County Clerk of Santa Fe County not later than Tuesday, February 4, 2014 at 5:00 P.M., the date on which the County Clerk will close registration books.
- H. All Declarations of Candidacy shall be filed with the Municipal Clerk on Tuesday, January 7, 2014 between the hours of 8:00 A.M. and 5:00 P.M.
- I. The casting of votes by qualified municipal electors shall be recorded on paper ballots and counted by the M100 electronic vote tabulators.
