

**TOWN OF EDGEWOOD
RESOLUTION NO. 2019-19
A RESOLUTION AUTHORIZING THE DISPOSITION OF TOWN OF EDGEWOOD
PERSONAL PROPERTY**

WHEREAS, the Town of Edgewood desires to dispose of multiple items of obsolete, worn-out or unusable tangible personal property listed and identified in Exhibit A, attached; and

WHEREAS, Section 13-6-1 and 13-6-2 NMSA 1978 govern the disposition of obsolete, worn-out or unusable tangible personal property owned by local public bodies; and

WHEREAS, each item of personal property on Exhibit A has a current resale value of less than \$5000; and

WHEREAS, the items of personal property on Exhibit A are obsolete, worn-out or unusable.

NOW, THEREFORE, BE IT RESOLVED by the Town of Edgewood Governing Body that:

1. The Governing Body of the Town of Edgewood approves of the disposal of the obsolete, worn-out or unusable tangible personal property on Exhibit A in accordance with NMSA 1978, Section 13-6-1 through 13-6-2; and
2. The Governing Body of the Town of Edgewood directs that, to the extent feasible, the personal property shall be sold at public auction, but if that is not feasible, it shall be disposed of as otherwise allowed by law.
3. A copy of this Resolution shall be sent to the Department of Finance and Administration Local Government Division at least thirty days prior to the deletion/disposal of the property.
4. A copy of the approval from the Department of Finance and Administration Local Government Division shall be submitted to the Office of the State Auditor.


