

**TOWN OF EDGEWOOD
RESOLUTION NO. 2022-28**

DESIGNATING WELLHEAD PROTECTION OVERLAY ZONES

WHEREAS, the Town enacted Ordinance 2022-07 which Ordinance adopted a comprehensive Zoning Ordinance and repealed Town Ordinance 2019-03; and

WHEREAS, Ordinance 2022-07 incorporates a new Section 25 creating overlay zones and addressing overlay zones for Wellhead Protection, Flood Protection, Airport Safety and Historic Districts and Landmarks; and

WHEREAS, the intent and purpose of the Wellhead overlay zone is to provide supplemental land use and development regulations in an area designated to protect the groundwater source of community water supply wells from contamination originating from human activities; and

WHEREAS, Ordinance No. 2022-07, Section 25, 1. Wellhead Protection, subsection 1(A) provides that designation of the Overlay Zone shall be created by resolution by the Governing Body; and

WHEREAS, Ordinance No. 2022-07, Section 25, 1. Wellhead Protection, subsection 1(D) provides among other things, that a Wellhead Protection Overlay Zone shall be delineated as a geographic area within a 1,000 foot radius around each "public water supply source", as recommended and defined by the New Mexico Environment Department; and

WHEREAS, the Governing Body seeks to designate geographic areas within a 1,000 foot radius around two identified "public water supply sources" as Wellhead Protection Overlay Zones.

BE IT RESOLVED BY THE GOVERNING BODY OF THE TOWN OF EDGEWOOD, NEW MEXICO:

Section 1. The following described real property and that geographic area within a 1,000 foot radius of the same is designated as a Wellhead Protection Overlay Zone:

T10N R7E Sec. 16 Edgewood, Santa Fe County New Mexico. 285 Dinkle Road. Parcel #99305585, UPC 1039058461068000000. Lat. 35.08346/ Long 106.19539

Section 2. The following described real property and that geographic area within a 1,000 foot radius of the same is designated as a Wellhead Protection Overlay Zone:

T10N R7E Sec. 24 Tract C-3, Edgewood, Santa Fe County New Mexico. 526 Dinkle Road. Parcel #99309643, UPC 1042057142408000000. Lat. 35.078793/ Long 106.153761

Section 3. The Town Manager is authorized to take any action necessary to carry out the directives of this Resolution.
